Subject: Creation of Telangana Telecom Circle and its functioning-regarding

The competent Authority has approved to initiate required preparatory actions towards creation of Telangana Telecom Circle by bifurcation of AP Telecom Circle and it is very likely that new circle starts functioning w.e.f. 01.10.2016 and the following steps are required to be initiated urgently:-

I.(a) Initiatives for space creation by construction of temporary shed (approximately 15000sq.ft) in the premises of PGM TD office and the existing space (approx. 12000 sq.ft) in the building of PGM TD, Vijayawada shall be done on or before 25.09.2016 positively.

(b) Requisition of land to State Govt. for constructing the proposed CGMs office at Amravati may also be placed immediately.

II The number of executives & Non-executives who have given option to work in new AP Circle HQ at Vijaywada on the basis of options called by AP Circles is enclosed as Annexure-I.

The approval of the competent authority for posting of these Executives and Non-Executives as per list (Annexure-I) is hereby given with the consideration that they will work at present place of posting till 30.09.2016 (including joining time, if eligible) and will report and start functioning in AP Circle , Head Quarter at Vijaywada w.e.f. 01.10.2016.

III Competent Authority has further considered postings in the grade of GM/Sr.GM/PGM in the Circle Office of AP Circle at Vijaywada effective from 01.10.2016 for whom orders will be issued separately and shortly.

IV. However, as the number of Executives & Non-Executives volunteered for new AP Circle are very less, so fresh option may be called with the following provisions:-

(a) Posting at Vijaywada will entail soft tenure facilities as one time measure.

- (b) For Non-Executives , PGM Vijaywada and adjoining SSA's of AP Circle (with HQ at Vijaywada) will arrange manpower to meet the requirement with similar benefits of (a) above.
- V. Creation of A/C in ERP is under process and PGM(CIT) has already issued instructions in this regard. Copy of instructions are enclosed herewith for ready reference.
- VI. Posting of IFA and sub-ordinate staff/accounts personnel shall be issued by GM(FP), BSNL CO, New Delhi, shortly.

The CGM, AP Circle will monitor all the related activities towards smooth roll out of the bifurcated Circle with immediate effect.
